

PCCYFS Report Evaluates the Needs Addressed by Children's Congregate Care Settings

PCCYFS released a report, Congregate Care for Youth: A Review of its Benefits, Principles, and Use in Pennsylvania. The report includes an overview of the principles and processes applied when identifying an appropriate placement setting for youth in Pennsylvania. It also outlines the various types of oversight to which congregate care settings are subject and other sources of data regarding the use of congregate care settings for Pennsylvania's young people.

"There is a lot of dialogue lately around the need and use of congregate care settings. While

the children's services system continues to move in the right direction by emphasizing community-based and home-like settings, there is still a subset of young people and children who continue to need more intensive support," said PCCYFS President and CEO, Terry L. Clark. "This report gives our system an idea of where service gaps exist. As we emphasize placement in community-based and home-like settings, it is important that we also build a comprehensive network of services that ultimately means that no young person, regardless of how complex their needs, are left behind."

PCCYFS is collaborating with PCYA and other partners to continue providing this opportunity to increase the understanding of, and collaboration on, the contracting process for child welfare and juvenile justice services. This training focuses on building a collaborative environment for the financial planning and contracting process by reviewing important timelines, discussing challenges from all perspectives, evaluating how data can play an important role, and outlining opportunities for technical support.

CWRC Diversity Task Force: Community Conscious Trauma Awareness

November 1, 2023 9 am – 12 pm

The Diversity Task Force 2023 virtual event is an interactive session presented by Sakia Foster and the PA Child Welfare Resource Center (CWRC) Diversity Task Force, to provide participants with opportunities to explore how systems of oppression, especially racism, generate unique forms of trauma for individuals and groups alike. Participants will focus on the consequences for those impacted by these unique forms of trauma and turn to the trauma-informed approach as a strategy for individual and collective healing. This workshop is intended for public and private child welfare professionals and is eligible for up to 3 continuing education credit hours.

Blueprint: Youth With Complex Needs

PA Department of Human Services (DHS) has convened a Blueprint Workgroup to develop recommendations to improve the systems that support youth (and their families) with complex needs. Meetings with the workgroup have been convened and updates will occur when information is received. DHS had a complex case steering committee in the past who

met and spoke about concerns with the current complex case referral process that is in place and the steering committee may regroup in the future to discuss recommendations from the Blueprint Workgroup. This Blueprint Workgroup (consisting of families and youth, county human services partners, behavioral health partners, providers, education) was brought together to discuss changing the current complex case process and look at ways of how PA DHS can support youth.
