

Department of Drug and Alcohol Programs, Fentanyl and Xylazine Test Strip Pre-order Information

The Pennsylvania Departments of Drug and Alcohol Programs (DDAP), Department of Health (DOH), and Pennsylvania Commission on Crime and Delinquency (PCCD) are working together to establish a new program that can provide organizations across the Commonwealth with a supply of Fentanyl and Xylazine test strips at no cost. The purpose of this pre-order form is to gather information from entities that may request test strips as the Commonwealth develops procurement-related processes to acquire and distribute them. Changes to PA's Family First Prevention Services Act Plan

On July 6, Pennsylvania Department of Human Services (PA DHS), Office of Children, Youth and Families (OCYF) submitted the 3rd version of Pennsylvania's Title IV-E Prevention Services Plan to the U.S. Department of Health and Human Services, Administration for Children and Families (ACF), electing the option of participating in the Title IV-E Prevention Services program given by the Family First Prevention Services Act (Family First). The Prevention Services program allows states to receive federal funding for evidence-based mental health prevention and treatment, substance use prevention and treatment, and inhome parent skill-based programs that are delivered to eligible children, youth, and families to help prevent the placement of a child into out-of-home care.

In response to feedback provided to OCYF by ACF, the 3 rd iteration of Pennsylvania's Title IV-E Prevention Services Plan provides greater detail into the following:

- Outcome and continuous quality monitoring (CQI) for the Evidenced-Based Programs (EBP) selected in the Prevention Plan;
- Evaluation strategy for the EBPs that will be undergoing rigorous evaluation; and
- Child welfare support & training, child safety monitoring, prevention caseload and eligibility criteria for PA's Community Pathways

In the 3rd submission of Pennsylvania's Title IV-E Prevention Services Plan, Positive Parenting Program – Group, Level 4 (Triple P – Group) has been removed due to challenges in meeting federal rigorous evaluation requirements given current low utilization rates by county children and youth agencies.
